Vanessa Packman	<p>Vanessa Packman is a Sussex Corner resident and lifelong animal advocate.</p> <p>As a member of the NBSPCA, she founded and leads the Kibble Pet Food Bank Network which has fed more than 25,000 animals since 2008. As creator and chair of the Fur Safety campaign, she's proud to have helped get nearly 70 pet oxygen mask kits to NB fire departments while getting pet owners to think of ways they can keep their pets safe.</p> <p>Her NBSPCA Rovers and Readers project has placed 700 literacy kits on animal welfare with New Brunswick children to date. And as co-ordinator of the unique NBSPCA Rover Map, she helps tourists, residents and EMS personnel find animal services around the Maritimes, while raising the NBSPCA's national profile.</p> <p>She has also served as newsletter editor and is a tireless advocate for spay and neuter and the Safe For Pets Too partnership.</p> <p>Her animal work outside of the NBSPCA includes helping create the UNESCO Fundy Biosphere as well as helping spay and neuter more than 600,000 animals worldwide.</p>
Poul Jorgenson	<p>Poul was born in Denmark and came to Canada in his very early years, growing up in Northern Alberta. After completing High School, Poul graduated from the Northern Institute of Technology and owned and operated his own retail flooring store.</p> <p>In 1986 Poul moved to New Brunswick continuing to work in his trade in the flooring industry. He and his wife Janice purchased a hobby farm in Three Tree Creek located just outside of Fredericton. They presently share their home with a dog, (a rescue dog) a cat and two horses. Over the years they have taken in rescue horses for the NBSPCA when Dave Lynch was the Animal Protection officer for the Fredericton area.</p> <p>In 2000 he became involved with the New Brunswick Trails Council joining the Board of Directors representing the equestrians. He sat on the board of New Brunswick Equestrian Association for 6 years representing the recreational division, serving as president for 2 years. In 2003 he joined the board of Equine Canada serving for a period of 3 years. In 2006 Poul joined the board of the Tri-county complex, a post he held for 6 years, serving as Vice President and working on several committees. Since 2001 Poul has worked for the NB Trail system where he currently holds the position of Executive Director.</p>
Barbara Hughes Campbell	<p>Barbara has been a longtime supporting member of the New Brunswick SPCA through the monthly PAW donation program. She grew up in Fredericton where she completed her BA at UNB in 1969. She travelled and worked for several years before returning to Dalhousie Law School from which she graduated in 1981. She was admitted to the New Brunswick Law Society in July of 1993. She has been in private practice for 33 years with the firm of Hughes Campbell where she is the principal; solicitor. She was appointed Queen's Counsel in 2001.</p> <p>An animal lover since her childhood, she shares her home and office with her poodle Maggie. Maggie is the official greeter in Barbara's law office and has been since June of 2011 following in the footsteps of Buddie who held the post until the age of 15.</p> <p>Barbara believes strongly in the importance of furthering the NBSPCA's mandate to improve the implementation of its animal welfare objectives, to wit, province-wide leadership in the humane treatment of animals, enforcement of relevant legislation, public education and advocacy and the protection of animals from abuse and neglect.</p> <p>She looks forward to being an NBSPCA board member at large for the 2-year term commencing in June 2017.</p>
